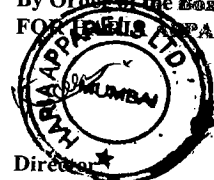

Review Report to the Board of Directors of HARIA APPARELS LIMITED.

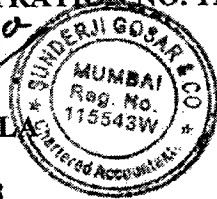
